1. March Minutes accepted. J.K. /J.G. (April Mtg. cancelled)
2. Briercliff Homeowners Assoc. request for decorative street signing tabled. J.K/P.R.
3. TSAB will send resolution to Town Board requesting approval of installation of Playground signing and Be A Good Neighbor signing for Woodway Ct. subdivision.
4. A letter will be sent to Erie County Highway requesting a study be conducted for installation of green left turn arrows at the signalized intersection of Clark St. and McKinley Park. Arrows will service traffic traveling on Clark St.
5. Request for stop sign @ Ridgeway & John Michael Way tabled. P.B./ J.K.
6. TSAB will send a resolution to Town Board requesting establishment of a No Standing Any Time traffic restriction w/ School Days sub panel on Fairway Court directly across from Pinehurst Elementary. A letter will be sent to Frontier Central school district offices informing them of this action. G.P./P.R.
7. A letter to Erie County Highway will be sent requesting an increase in present stop sign dimensions from 30x30 to 36x36 on Taylor Road @ its intersection with East Eden Road. TSAB will also request installation of a Stop Bar on pavement. Request is being made to address resident concerns and that of recent accidents at this location. J.K./P.B.
8. TSAB will send letter to Saint Francis High School requesting their cooperation in alleviating parking problems on Big Tree Road adjacent to the schools sports fields.

Site Plan Review:

Whispering Pines, TSAB requests Planning Board require the installation of R1-1 Stop sign at this subdivision road (unnamed) at its intersection with Brompton Parkway. TSAB has no other comments/recommendations at this time. G.P/ C.G.

Brookview Apartments, TSAB requests Planning Board require a secondary means of egress from this complex onto Summerway Lane located in the Four Season subdivision. It also recommends that means of egress from Brookview Apartments onto Summerway Lane be gated, only to be used during times of emergencies. No other comments or recommendations at this time. J.G./J.
